4. Award criteria of the tenders and summary of the tenders.

A tender was based on the following criteria:

No.	Type of the criteria	Score	Evaluation method
1.	Price	From 0 to 60	Ratio of the lowest prices to the price in the rated tender, multiplied by 60.
2.	Payment period	From 0 to 20	Ratio of the payment period in the rated tender to the payment period in the tender with the longest payment period, multiplied by 20.
3.	Warranty	From 0 to 10	Ratio of the warranty period in the rated tender to the warranty period of the tender with the longest warranty period, multiplied by 10.
4.	Realization period	From 0 to 10	Ratio of the shortest realization period to the realization period in the rated tender, multiplied by 10.

The maximum number of points possible to achieve was 100.

Taking into account the above criteria, bids presented by the tenderers in the contest of tenders obtained the following scores:
