### 14. The bid bond.

Contractors are required to pay a deposit (bid bond). The conditions for filing and refund the deposit are as follows:

1. The amount of the bid bond

It is recommended to submit with the offer a copy of the bond document (pledge / guarantee). It allowed to submit the original of a bond document directly in the offer.

4. The deadline for the lodging of bid bond

- 1) The bid bond shall be lodged before the deadline for submission of the tenders, the contribution of the deposit in cash via bank transfer to the Buyer will be considered effective only if the amount of the deposit account will affect the Buyer account prior to the deadline for submission of tenders.
- 2) In the above case, attachment of the copy of the bank transfer is desired condition, but not sufficient for a finding by the Buyer timely bid bond by the Contractor.
- 3) The Buyer requests re-bid bond by the Contractor, who paid the deposit after the selection of the best bid, or cancellation proceeding, if, upon settlement of the appeal his offer was chosen as the most advantageous. The Contractor shall pay a deposit within the period specified by The Buyer.

- 4) Brought in cash, together with interest resulting from the bank account agreement, where it was stored, reduced by the costs of running a bank account and bank fees for transferring money to the bank account indicated by the Contractor.
- 6. The Buyer will seize the bid bond with interest, if:
- 1) The Contractor in response to the call, referred to in art. 26 paragraph. 3 of the PPL, for reasons attributable to him, did not submit the relevant documents or statements, which resulted in the inability to select the tender submitted by the Contractor as the most advantageous.
- 2) The Contractor, whose offer was chosen, refused to sign the contract under the conditions specified in the offer.
- 3) The conclusion of the contract became impossible for reasons attributable to the Contractor.

15. Information on how the price is calculated.

- 1.
